- Festival will provide signage & two tables inside a 10x10 tent, lights and one 110 volt 20 amp outlet (2 plugs)
- Vendors can purchase additional electricity if needed EXTRA ELCETRICITY NEEDS:_____VOLTS_____AMPS
- Vendors provide their own paper products, cooking utensils, warming units and sterno
- Booth spaces are all 10 x 10 in size and are required to be open during festival hours, if you need more tent space please speak to Jenny about a second booth rental
- NO REFUNDS shall be made for inclement weather or other ACTS of GOD over which the Festival has no control. The exhibitor bears the risk of loss in such instance.
- SECURITY will be present on the grounds during the entire festival weekend. The Festival accepts no responsibility for stolen or damaged property, or accident or injury.

INSURANCE:

The insurance company for the City of Kenner as well as the Kenner Italian Heritage, Inc. requires that all vendors for the Festival provide a certificate of insurance. This certificate must provide the following limits: 1,000,000 EACH OCCURRENCE; 1,000,000 GENERAL AGGREGATE; 1,000,000 PRODUCTS/COMPLETED OPERATIONS AGGREGATE.

The Clty of Kenner and The Kenner Italian Heritage, Inc. must be named as ADDITIONAL INSURED and provided with a waiver of subrogation.
